INFORMATIONAL

Summer Programming – Dr. Weller noted the following summer programs held across the district this summer:

- *Success by Six*, held in cooperation with the United Way, is preparing at-risk incoming kindergarten students for the new school year. The program is housed at Smedley Elementary School and has thirteen students participating.
- *Summer Camps* are being held to address learning loss and are funded by ESSER funds. The camps, held for two weeks in July and two weeks in August, are housed at the Oil City Middle School and are open to all elementary students. Approximately twenty-five to thirty-five students are participating in each session.
- Extended School Year (ESY) is offered to a number of special education students to prevent learning loss over the summer months.
- *Credit Recovery* was offered to high school students, but was cancelled due to lack of need. During the 2021-2022 school year, credit recovery time was built into tenth period. Due to the success of that practice, it will continue to be offered in the future.

Rural Pennsylvania COVID-19 School Toolkit – Dr. Weller shared that Oil City Area School District's Health and Safety Plan was highlighted in the recently released Rural Pennsylvania COVID-19 School Toolkit as an innovative example.
