ADMINISTRATORS' REPORTS

Mrs. Highfield provided an update regarding Hasson Elementary. Kindness Week was celebrated with theme days, activities, as well as videos sent to classrooms for use. Several teachers participated in a "goose chase" along with 16 families. February is Black History month, and resources were sent to teachers, with 3rd and 4th grade using them for research. Kindergarten and 1st grade attended *The Rainbow Fish* musical at The Barrow. 2nd grade will attend *Alice in Wonderland*, which is being funded by Jamie's Kids to send all area 2nd grade students to the performances. 3rd and 4th grade students completed a bowling unit with Mrs. McVay and were able to show off their skills at the bowling alley. Presidential trivia has been incorporated in the morning for students to show off their knowledge of our Presidents to celebrate Presidents' Day. March has several activities scheduled, including Donuts with Dad, Dr. Seuss Week and Read a Thon, 4th grade play, and Family Night. GEMS after school program has wrapped up, and students are looking forward to Robotics kicking off in March. In April, a Career Day is scheduled. Mrs. Highfield noted that they are looking for staff

and parent volunteers to participate. The school was challenged to complete 500 random acts of kindness throughout the month of February, and if successful, Mrs. Highfield and Mr. Siembida promised to make a pancake breakfast.

Mrs. Highfield provided Mr. Kasunic's update, which highlighted the PETE+C Conference. Three Middle School teachers attended, two of which teach Intro to Engineering and Robotics, and made connections to enhance their curriculum. Kim Eberle and Erika Smith, who are part of the Business and Technology Department, have joined PAECT (Pennsylvania Association for Educational Communications and Technology). Suzi Fox has found interactive, collaborative, and hands-on activities that can be used immediately in her ELA classroom. She looks forward to getting the students working together to create more diverse and collaborative conversations and connections. Appreciation and thanks offered for the ongoing opportunity to attend this statewide conference to help grow professional careers. Middle School math teachers are collaborating with Brockway to work with a teacher that has consistently scored higher than other schools in our IU6. They are seeking details of scheduling, curriculum, and pacing to improve math scores. Academic Biology students were challenged to a speed DNA building contest with boys versus girls. It was a close match, but the boys won by about 15 seconds.

Mrs. Shuffstall noted that classroom observations and interventions are conducted and provided as needed, including support for interventions for High School and Middle School Emotional Support students. In an ongoing effort, parent/IEP meetings are being held to refine behavior plans and manage IEP support to ensure student success. Continued planning for Emotional Support programs and individual student and staff support remains. High School Emotional Support students were able to attend monthly incentives, including an in-classroom Christmas party, travelling to Jumbo Buffet, and Tickle My Ribs BBQ. A Semester incentive was offered to earn a trip to Round 1 and Sonic in Erie. Mrs. Shuffstall also noted that she has been working through a new book and resource, "Highly Engaged Classroom."
